Please see the following page for additional information on accepted proofs of residency.

Please note, if you are not eligible for California residency, you may qualify for a California Non-resident Tuition Waiver. You must have attended a California high school for 3 or more years and have graduated, and may not be a current nonimmigrant alien as defined by federal law to be eligible. You must complete an AB540 affidavit and present your official high school transcript to request the waiver.

Eligibility for California Residency:

1. You must be a United States citizen, permanent resident, asylee/refugee, DACA, or have a visa status that is eligible to establish residency. That includes the following visa categories: A 1-3, E 1-3, G 1-5, H-1B, H-1C, H4 (if dependent of H-1B or H-1C), I, K 1-4, L-1A, L-1B, L-2, NATO 1-7, N-8, N-9, O-1, O-3 (if dependent of O-1), R 1-2, T 1-5, U 1-5, and V 1-3.
2. You must have lived in California under a residency eligible immigration status for at least one year and one day prior to the start of the term for which you seek residency.

The following immigration statuses are **not** eligible to establish residency: B-1/B-2, C 1-4, C-1D, D 1-2, F 1-3, H-1B1, H-2A, H-3, H-4 (if dependent of excluded H type visa), J 1-2, M 1-3, O-2, O-3 (if dependent of O-2), P 1-4, Q 1-2, S 5-7, TWOV, TN and TD, aliens under an order of supervision or parole, BCC or BE entrants, VWP (ESTA), undocumented and out of status students

***Please note, this list is may not include all visa statuses and immigration types. If your status is not listed, please speak with us at the Admissions Office for additional information.*

Residency Documents:

You must provide a valid photo ID and 2 of the following documents

- Property tax forms for prior year
- Rental or lease agreements (Lease terms of 6 months or more required. Month to month agreements cannot be used.)
- California voter registration, must be dated and clearly list student name
- California state income tax returns for prior year (Form 540 resident state tax return)
- California driver license or state ID
- Active checking or savings accounts in California banks - you must submit one statement from at least a year and a day prior to the start of the term you would like to declare residency in, and one current statement.
- **If attending an out of state college within the last year**, tuition statements showing non-resident or flat fee tuition paid at the out of state institution must also be submitted.

Other documents may be considered on a case by case basis.

***If you are 19 years of age or younger, you can use a California tax return from your parent or guardian as a proof of residency, provided you were claimed as a dependent in that year.*

General Residency Guide:

Status	<u>Resident in CA for two or more years per answers to application questions.</u>	<u>Resident in CA for less than 2 years</u>	<u>Current stay in CA began less than one year and a day prior to the start of term</u>
Citizen	No documentation required in most cases. Naturalized citizens may need to provide U.S. Passport or Certificate of Naturalization	Student must submit 2 proofs of residency dated at least one year and one day prior to the start of the term residency is requested for.	Not eligible for residency until the one year period is complete and can be documented.
Non-Citizen (anyone other than a US Citizen)*	Documentation of residency eligible immigration status required. Status must be documented for at least one year and one day prior to the start of term.	Documentation of valid immigration status and 2 proofs of in state residency required. Immigration and residency documents must be dated no later than one year and one day prior to the start of term.	Not eligible for residency until the one year and a day period is complete and documented. The student must maintain a residency eligible immigration status for that period as well.
Military/Veterans/ Military Dependents	Documentation of immigration status is required for non-citizens. US citizens do not need to submit additional documents.	Completion of the CA Active Duty Member/Dependents/Veterans Non-Resident Tuition Exemption form and documentation presented to the Financial Aid Office.	Completion of the CA Active Duty Member/Dependents/Veterans Non-Resident Tuition Exemption form and documentation presented to the Financial Aid

**Please note, students on a B1/B2 visa that have not been granted any other status may not attend due to federal immigration regulations.*
