



## NON-RESIDENT TUITION EXEMPTION REQUEST FOR MILITARY/VETERAN/DEPENDENT

If you do not meet any of the criteria below but have been physically living in CA for more than one year immediately prior to the term, please submit the change of residency form with supporting documents to Admissions and Records department.

1. **CA ACTIVE DUTY MEMBER:** YES NO

**Document needed:** Please provide copy of the active military member's travel orders to CA or statement of commanding officer AND evidence showing you are a dependent of a military member for federal tax purposes.

b) Veterans Access, Choice, and Accountability Act-VACA (Effective Fall 2015):

b) VACA/AB13 (effective Fall 2015 for Chapter 30/33; effective Summer 2019 for Chapter 31):
